### **STATE PROPOSAL 22-1**

A proposal to amend the state constitution to require annual public financial disclosure reports by legislators and other state officers and change state legislator term limit to 12 total years in legislature This proposed constitutional amendment would:

Require members of legislature, governor, lieutenant governor, secretary of state, and attorney general file annual public financial disclosure reports after 2023, including assets, liabilities, income sources, future employment agreements, gifts, travel reimbursements, and positions held in organizations except religious, social, and political organizations. Require legislature implement but not limit or restrict reporting requirements. Replace current term limits for state representatives and state senators with a 12- year total limit in any combination between house and senate, except a person elected to senate in 2022 may be elected the number of times allowed when that person became a candidate.

#### **STATE PROPOSAL 22-2**

A proposal to amend the state constitution to add provisions regarding elections.

This proposed constitutional amendment would:

Recognize fundamental right to vote without harassing conduct; Require military or overseas ballots be counted if postmarked by election day; Provide voter right to verify identity with photo ID or signed statement; Provide voter right to single application to vote absentee in all elections; Require state-funded absentee-ballot drop boxes, and postage for absentee applications and ballots; Provide that only election officials may conduct post-election audits; Require nine days of early in-person voting; Allow donations to fund elections, which must be disclosed; Require canvass boards certify election results based only on the official records of votes cast.

# **STATE PROPOSAL 22-3**

A proposal to amend the state constitution to establish new individual right to reproductive freedom, including right to make all decisions about pregnancy and abortion; allow state to regulate abortion in some cases; and forbid prosecution of individuals exercising established right

#### This proposed constitutional amendment would:

Establish new individual right to reproductive freedom, including right to make and carry out all decisions about pregnancy, such as prenatal care, childbirth, postpartum care, contraception, sterilization, abortion, miscarriage management, and infertility; Allow state to regulate abortion after fetal viability, but not prohibit if medically needed to protect a patient's life or physical or mental health; Forbid state discrimination in enforcement of this right; prohibit prosecution of an individual, or a person helping a pregnant individual, for exercising rights established by this amendment; Invalidate state laws conflicting with this amendment.

# SALINE AREA SCHOOLS BONDING PROPOSAL

Shall Saline Area Schools, Washtenaw County, Michigan, borrow the sum of not to exceed One Hundred Eighty Million Dollars (\$180,000,000) and issue its general obligation unlimited tax bonds therefor, in one or more series, for the purpose of: erecting, furnishing and equipping additions to school buildings; erecting, furnishing and equipping a new transportation/operations facility; remodeling, equipping and reequipping and furnishing and refurnishing school buildings; acquiring, installing and equipping or reequipping school buildings for instructional technology; purchasing school buses; erecting and equipping athletic structures and facilities; and acquiring, preparing, developing, improving and equipping playgrounds, athletic fields and sites? The following is for informational purposes only: The estimated millage that will be levied for the proposed bonds in 2023, under current law, is 0 mill (\$0.00 on each \$1,000 of taxable valuation). The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty (20) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 3.28 mills (\$3.28 on each \$1,000 of taxable valuation). The school district expects to borrow from the State School Bond Qualification and Loan Program to pay debt service on these bonds. The estimated total principal amount of that borrowing is \$539,795 and the estimated total interest to be paid thereon is \$2,552,155. The estimated duration of the millage levy associated with that borrowing is 9 years and the estimated computed millage rate for such levy is 7.50 mills. The estimated computed millage rate may change based on changes in certain circumstances. The total amount of qualified bonds currently outstanding is \$88,430,000. The total amount of qualified loans currently outstanding is approximately \$7,840,193. (Pursuant to State law, expenditure of bond proceeds must be audited and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)
