## **Regular Meeting October 9, 2017 Page 1 of 2**

1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on October 9, 2017 at 7:00PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Treasurer Luckhardt, Clerk Marion, Trustee R Prehn and Trustee R Marion. Seven other citizens were present.
3. Mr. R. Prehn led the Pledge of Allegiance.
4. Mr. R. Marion moved, supported by Mr. R. Prehn that the agenda be approved as presented.
5. Mr. R. Marion moved, supported by Mr. R. Prehn that the consent agenda be approved with one correction. (c) Change September to October
  - a. Approve minutes from September 11<sup>th</sup> regular meeting
  - b. Receive Clerk's budget, Financial Report
  - c. Approve accounts payable for October in the amount of \$6,017.37
  - d. Approve October payroll in the amount \$6,026.13
6. Citizen Comments - Citizens were offered a chance to address the Board regarding items not already on the agenda. A representative from the Board at Riverridge Association addressed the Saline Township Board with their concerns of Andelina Farms hooking into the current water and sewer system, a formal letter to follow to the Township Board from their counsel. The Township Board stated that current judgment stands which states no additional hookups. Another point made was that the property should be part of the City of Saline, that the city is missing out on a development that all parties new would come to the table at some point based on both master plans in place.
7. Supervisor's Report
  - a. Sheriffs Report several traffic violations no major incidents.
  - b. Andelina Farms to attend the November Board meeting.
  - c. Macon Road Bridge is currently out and is expected to be out until next spring. The process of getting the bridge replaced is in the beginning stages further information to follow as the Board is updated by WCRC.
  - d. Short Term Rental Properties/Legislation- the Board's council has encourage the board as well as the residence to review the legislation (House Bill 4503 and Senate Bill 329) and if not agreeable to contact their states representative. This bill would allow homes in residential areas to essentially become hotels, shot tern leases the home never having to be owner occupied. Further more it would take the governing away from the local municipalities.
  - e. At this time the Board is not taking on vote on the new medical marijuana legislation.

8. Trustees Report- the Planning Commission met in October and was unable to grant a special use permit for an auto repair shop however they did fall under our non-conforming use do to the time the business has been in operation. It was suggested that the township provide shredding at the next spring clean up; Mr. Prehn looking into the cost.

10. Fireboard Report- the audit is taking place. Still working on the details for forming the Union.
11. Township Hall Manager Report- floors to waxed this winter.
