1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on April 11, 2016 at 7:00PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Clerk Marion, Treasurer Luckhardt, Trustee R. Marion and Trustee R. Prehn. Eighteen other citizens were present.
3. Mr. R. Prehn Marion led the Pledge of Allegiance.
4. Mr. R. Marion moved, supported by Mr. R. Prehn that the agenda be approved with one correction; 7b- Spring Clean up 8am-2pm.
5. Mr. R. Marion moved, supported by Mr. R. Prehn, that the consent agenda be approved as presented.
 - a. Approve minutes from March 14th regular meeting and March 14th Special Meeting/Budget.
 - b. Receive Clerk's budget, Financial Report
 - c. Approve Accounts payable for March in order to close out the Fiscal Year 2015-2016 in the amount of \$8,673.94
 - d. Approve Accounts payable for April in the amount of \$1,916.94
 - e. Approve Saline Fire Department Operating Fourth Quarter in the amount of \$26,012.82.
 - f. Approve March payroll in the amount of \$3,315.36 in order to close out Fiscal Year 2015/2016
 - g. Approve April payroll in the amount of \$5,631.75
6. Citizen comments- one residence questioned as to weather or not the Township has a Blight Ordinance; we do and it is enforced. Said residence would like the township to have a refrigerator removed that has been sitting in a driveway for some time, Mr. R. Marion looking into it. Randy Clark introduce himself to the Board and residence informing the audience that he will be running for State Representative.
7. Supervisor's Report
 - a. Sheriff's Report- Several traffic violation however no major incidences.
 - b. Spring Clean Up- May 21 8am-2pm
 - c. McMann Drain- Drain Commission to attend the June meeting to discuss the McMann drain; a letter will go out to each resident that is on the drain.
 - d. US 12 Traffic- Current plan is to send all traffic on US 12 in one direction, West and directed the East traffic all one way on Henry Street adding a light at the intersection of Henry and Saline Ann Arbor.

8. Road Commission – Roy Townsend of Washtenaw County Road Commission and other staff members were in attendance to present the Commissions 2016 Annual Report. There were many concerns from the residence; these concerns included the following: snow removal, ditching, regular maintenance of the roads and tree trimming. The Road Commission was or is now a wear of specific concerns and will address them as they can. Currently short on staff and funds; they are doing what they can with what they have to work with. Several requests were made to have the township serviced by the Manchester yard. Hack Rd Bridge to get started this summer and the Willow Rd Bridge by late summer early falls. Several residences commended the Road Commission on their work.
9. Trustees Report- Mr. Prehn met with the planner and reviewed the first five chapters of Master Plan, chapter six to follow by the next meeting. The public meeting to be held on April 12 has been cancelled, however the regular meeting is still scheduled for that same night.
10. Zoning/Building Administrator Report- letters going out to owners of the abandoned buildings in the township.
11. Fireboard Report – Approved budget. Applications available for the three job openings as full time fire fighters.
