1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on October 12, 2015 at 7:30PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Clerk Marion, Treasure Luckhardt, Trustee Marion and Trustee Prehn. Two other citizens were present.
3. Mr. Prehn led the Pledge of Allegiance.
4. Mr. R. Marion moved, supported by Mr. Prehn that the agenda be approved as presented.

  - b. Hack Road Bridge. The Township Board is moving forward with the repair/replacement of the Hack Road Bridge. The estimated cost to Saline Township will be \$62,500. Total cost is approximately \$250,000 split between Saline Township, WCRC, Macon Township and LCRC.
  - c. Saline River Preserve – at this time Saline Township will not be committing to the Preserve.
  - d. Board Meeting 7PM- A **MOTION** was made by Mr. R Marion and supported by Mr. Prehn to start the Township Board and Planning Commission meetings at 7PM starting January 2016. Ayes 5 Nays 0
  - e. Master Plan Meeting - The Saline Township Board met with the Planning Commission and the township planner Doug Lewan to discuss the updated Master Plan. At this time Mr. Lewan will be working on changing the master plan to make it more user friendly and updating the current maps. Further updates to follow in the up coming months.
  - f. Arkona Bridge- currently the bridge has started construction; estimated completion is the week of October 19.
