1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on June 9, 2014 at 7:30PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Clerk Marion, Treasurer Gordon, Trustee R. Marion & Trustee R. Prehn. Three other citizens were present.
3. Mr. R. Prehn led the Pledge of Allegiance.
4. Mr. R. Marion moved, supported by Mr. R. Prehn that the agenda be approved as presented.
5. Mr. R. Marion moved, supported by Mr. R. Prehn that the consent agenda be approved as presented.

 - b. Receive Clerk's budget, Financial Report
 - c. Approve accounts payable for June in the amount of \$6,560.07

6. Citizen Comments - Citizens were offered a chance to address the Board regarding items not already on the agenda. No citizen comments.
7. Supervisor's Report
 - a. Sherriff's Report- 48 calls in the month of April no major incidents.
 - b. Lime Stone Project- a **MOTION** was made by Mr. R. Marion and supported by Mr. R. Prehn to move forward with WCRC Lime Stone Project in the amount (not to exceed) of \$80,000 and to amend our current budget for said project from \$60,000 to \$80,000.
 - c. County Clean Up June 14 9am-2pm 8350 Main Street Whitmore Lake
 - d. Feldkamp Bridge is being paved the week of June 9 and should be open by the week of June 16. Supervisor Marion to attend ribbon ceremony if the WCRC choose to host one.
 - e. Washtenaw Urban County – the township is automatically renewed for the next three years at no cost to the township.
 - f. Zoning Ordinance – The township planner will be working on the updated zoning ordinance for the Board to review and approve.
 - g. Saline Ventures to meet with Supervisor Marion and the township attorney to talk about their plans for a special use permit, additional Board member may attend.

8. Trustees Report – Mr. Robert Prehn reported that Scio Township has passed a resolution with regards to restricting oil drilling; currently the State Regulations this process. Mr. Prehn also brought to the Boards attention that there is currently a resident that is in violation of the number of persons living on their property; said residents attended the planning commission in June and were more than willing to work with the township in order to comply.
9. Zoning/Building Administrator Report – Mr. R Marion reported on some complaints being received by neighbors on each other; Mr. Marion has advised them to call law enforcement. Complaints have been received due to lack of lawn maintenance; currently the township does not have a lawn ordinance however we have a property maintenance ordinance which will be enforced. Cars are being parked on a commercial property located in the township owner of said property has been notified by the township attorney to remove them; that this is a violation of our ordinance.
10. Fireboard Report – Evaluation on the Chief of Saline Fire Department went very well.

12. Board Member Comments – Mrs. Judy Gordon informed the Board that the township has two escrows that are still being held from years ago; the Board has decided to continue these escrows as both are still active ventures in the township.
