## Regular Meeting July 8, 2013 Page 1 of 2

1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on July 8, 2013 at 7:30PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Clerk Marion, Treasurer Gordon. Trustee R. Marion and Trustee R. Prehn were absent. Three other citizens were present.
3. Ms. K. Marion led the Pledge of Allegiance.
4. Ms. Kelly Marion moved, supported by Mrs. Judy Gordon that the agenda be approved as presented.
5. Mrs. Kelly Marion moved, supported by Mrs. Judy Gordon, that the consent agenda be approved with one correction, 7(b).

  - b. Receive Clerk's budget, Financial Report
  - c. Approve accounts payable for July in the amount of \$1,886.66
  - d. Approve July payroll in the amount \$5,311.48
6. Citizens were offered a chance to address the Board regarding items not already on the agenda. One citizen comment. Mary Gumtow reported that the Spring Clean Up went very well. Next year two trucks instead of three will be needed. A County Wide Clean Up should take place in the fall, further information to be placed on the Township web site.
7. Taylor Jacobson – Presented to the Board information with regards to the Saline River Greenway Alliance. The program informs the residents through a brochure on what's being done and what needs to be done in order to maintain the river side. A **MOTION** was made by Ms. Kelly Marion and supported by Mr. James Marion to renew the \$100 dollar fee to SRGA. Ayes 2 Nays 1 Mr. Robert Marion and Mr. Robert Prehn were absent.
8. Supervisor's Report
  - a. DEQ- Saline Township has joined FEMA. The gravel pit on Michigan Avenue has currently been turned down for expansion.
  - b. Bridgewater Carpentry - A **MOTION** was made by Ms. Kelly Marion and supported by Mrs. Judy Gordon to approve the estimate from Bridgewater Carpentry with an addition \$2,200 dollars added for a total not to exceed \$6,000. Estimate was for replacing the handicap ramp and replacement of the concrete sidewalk/approach/steps. Ayes 3 Nays 0 Mr. R. Prehn and Mr. R. Marion were absent.
