## **Regular Meeting December 13, 2010 Page 1 of 2**

1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on December 13, 2010 at 7:30PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176
2. Members present: Supervisor Marion, Clerk Marion, Treasurer Gordon and Trustee Mr. R. Marion. Trustee R. Prehn was absent. Six other citizens were present.
3. Mrs. Kelly Marion led the Pledge of Allegiance.
4. Mrs. Judy Gordon moved, supported by Mrs. Kelly Marion that the agenda be approved as presented.
5. Mrs. Judy Gordon moved, supported by Mr. R. Marion, that the consent agenda be approved as presented.
  - a. Approve minutes from November 8 regular meeting
  - b. Receive Clerk's budget, Financial Report
  - c. Approve Accounts Payable in the amount of \$5,365.90
  - d. Approve December Payroll on the amount of \$5,186.99
  - e. Approve Final bill to WCRD for brine and the Road Improvement Program in the amount of \$13,601.61
  - f. Election to be held on February 22, 2011
  - g. Decline participation with The River Raisin Watershed Council
6. Citizens were offered a chance to address the Board regarding items not already on the agenda. No citizen comments.
7. Board of Review was sworn in.
8. Supervisor Marion commented on the following:
  - a. Cemetery Plots – At this time the cost of the plots will be the same whether you are a Township resident or not.
  - b. Fred Lucas – Has filed and registered all the paper work for the tax tribunal hearing to be held in July of 2011.
  - c. Reappoint members for the Planning Commission/Zoning Board – Charles Rankin and Gary Luckhardt were reappointed to the Planning Commission and Judy Gordon and Richard Zahn were reappointed to the Zoning Board of Appeals.
  - d. Gravel Pit inspections are complete. 2010 Mapping to follow.
9. Trustees Reported that the Planning Commission had their December 7 meeting and that A & H Landscaping was approved for their special use permit.
10. Zoning Report – Still an ongoing issue with the dogs in Oak Park. Mr. R. Marion is

looking into what the township can do. It appears that at the present time the association for Oak Park is not being enforced.

11. Fireboard reported that their budget meeting will be held in January. No union to be formed at this time. However, the criteria for hiring was changed slightly.
12. Township hall manager reported that the fence at Oak Hill Cemetery will need to be replaced as well as the door at Union Cemetery.
13. FOIA – Fees were tabled until January’s meeting.
