## **Regular Meeting July 9, 2018 Page 1 of 2**

1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on July 9, 2018 at 7:00PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Clerk Marion, Treasurer Luckhardt, Trustee R. Marion and Trustee R. Prehn. Three other citizens were present.
3. Mr. R. Prehn led the Pledge of Allegiance.
4. Mr. R. Marion moved, supported by Mr. R. Prehn that the agenda be approved as presented.

Supervisor Marion will discuss this with the township planner and a fee will be established so that Mr. Milky can move forward with his application request.
