1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on May 12, 2021 at 7:00 PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Clerk Marion, Treasurer Zink, Trustee R. Marion and Trustee Hammond. Five other citizens were present.
3. Mr. Hammond led the Pledge of Allegiance.
4. Mr. R Marion moved, supported by Mr. Hammond that the agenda be approved with two corrections (e) site plan approval Nick Armstrong (f) resolution to impose moratorium upon insurance of Special Use Permits Ayes 5 Nays 0.
5. Mr. R. Marion moved, supported by Mr. Hammond, that the consent agenda be approved as presented. Ayes 5 Nays 0
 - a. Approve minutes from April 14th regular meeting
 - b. Receive Clerk's budget, Financial Report
 - c. Approval payroll for May in the amount of \$7,540.38
 - d. Approval accounts payable in May in the amount of \$11,492.28
 - e. Assessing to WCED in the amount of \$20,000 for the year 2021.

7. Supervisor's Report
 - a. Sheriff's Report- no major incidents.
 - b. Andelina Farms- a progress meeting to take place in the next few weeks, an update to follow at the June Regular Board Meeting.
 - c. Spring Clean Up May 15 8:00am – 1:45pm
 - d. Solar Farms- no application filed at his time. Possible presentation to take place at the June 1 Planning Commission meeting.
 - e. Nick Armstrong Site Plan Approval- a **MOTION** was made by Mr. Hammond and supported by Mr. R. Marion to approve the site plan for Nick Armstrong's development of 12 dwellings. Ayes 5 Nays 0.
 - f. Resolution for a Moratorium- a **MOTION** was made by Mr. Hammond and supported by Mr. R. Marion to adopt the resolution to impose a temporary moratorium asking the Planning Commission to amend the zoning ordinance to allow the Township Board to have final authority for issuance of Special Use Permits, this moratorium will be in effect for six month and will not include any Special Use Permits that were submitted prior to May 12, 2021. Ayes 5 Nays 0. This request will be a discussion at the June 1 Planning Commission meeting with a public hearing to follow in July.

9. Zoning/Building Administrator Report – Fred Lucas will be issuing notices to those residents who are not in compliance with fallen down structures on their property.
10. Fireboard Report- a new chief was hired.
11. Township Hall Manager Report- looking to have a security system installed to monitor the recycling, currently several items that are not considered recyclable are being disposed of and in return an additional cost to the township is incurred. Fred Lucas will be working on an ordinance that will impose this as a civil infraction, and one could be prosecuted.
12. Board Member Comments – Treasurer Zink has chosen Invoice Cloud to handle on line tax payments: due to the numerous requests for on line payment she has inquired in to several companies and this one is the best for for Saline Township. A **MOTION** was made by Mr. Hammond and support by Mr. R Marion to amend the 2021/2022 budget to include \$1500 in expense for the service. Ayes 5 Nays 0
