  - d. Limestone Project- a MOTION was made by Clerk Marion and supported by Treasures Zink to moved forward with the Limestone project not to exceed \$214,000. Ayes 5 Nays 0. A MOTION was made by Trustee Marion and supported by Trustee Hammond to use \$54,000 of the ARPA funds toward the overall cost of the project. Ayes 5 Nays 0.

- 8. Trustee's Report- Mr. Hammond reported on the follow: Board of Review is being held March 13 from 3pm-9 pm and March 14 from 9 am -3 pm. SAFS expressed their concerns of the Jupiter batterie project: currently no resources to put such a fire out if one should happen or the manpower. At this time the township to further research such a project and the impact it would have, an ordinance regarding batterie storage to be put in place once the township has completed their due diligence. Clean up needed at the cemeteries due to tress/branches coming down after winter storms.
- 9. Zoning/Building Administrator Report Attorney Fred Lucas to issue second letters to those residence who are not in compliance with the blight ordinance.
